## RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNIFICATION

### 1. Activities Covered

This Agreement applies to my participation in firearms-related activities offered, organized, supervised, or facilitated by RangeBuddy Shooting LLC (the "**Company**"), including classroom instruction, dry-fire practice, live-fire exercises, range visits, use of rental firearms or equipment, ammunition use, firearm handling and cleaning demonstrations, holster work, movement drills, defensive-shooting exercises, and transportation provided or arranged by the Company, if any.

### 2. Acknowledgment of Inherent Risks

I understand that firearms and shooting activities are inherently dangerous and may result in property damage, serious bodily injury, permanent disability, or death. Risks include, without limitation, accidental or negligent discharge; ricochet or fragmentation; flying brass; excessive noise; lead or chemical exposure; firearm or ammunition malfunction; burns; trips and falls; weather; acts or omissions of other participants; and delayed or unavailable emergency care. I understand that this list is not complete and that unknown or unexpected risks may arise.

### 3. Voluntary Assumption of Risk

I voluntarily choose to participate with knowledge of these risks. To the fullest extent permitted by law, I knowingly accept and assume all risks of injury, death, loss, or damage arising from or related to my participation, including risks arising from ordinary negligence, the condition of equipment or facilities, or the conduct of other participants.

### 4. Safety Rules and Participant Responsibilities

- I will treat every firearm as if it is loaded and keep it pointed in a safe direction.
- I will keep my finger outside the trigger guard until on target and authorized or ready to fire.
- I will know my target, its surroundings, and what is beyond it.
- I will immediately obey all instructor, Range Safety Officer, and host-range commands.
- I will wear required eye and hearing protection and use only approved firearms and ammunition.
- I will not participate while impaired by alcohol, cannabis, illegal drugs, or any medication or condition that makes participation unsafe.
- I will report unsafe conditions, injuries, equipment defects, and ammunition malfunctions immediately.
- I understand that unsafe conduct may result in immediate removal without refund.

## 5. Health and Fitness Representation

I represent that I am physically and mentally capable of participating safely. I will disclose to the instructor any condition, limitation, medication, allergy, hearing concern, vision concern, or accommodation that may affect safe participation. I understand that the Company does not provide medical advice or determine my fitness to participate.

## 6. Release and Waiver of Claims

To the fullest extent permitted by New Jersey law, I release and discharge the Company and its owners, members, managers, employees, instructors, Range Safety Officers, assistants, contractors, volunteers, host ranges, property owners, affiliates, sponsors, and agents (collectively, the "Released Parties") from claims, demands, causes of action, damages, losses, or expenses arising from or relating to my participation, including claims based on ordinary negligence. This release does not apply to conduct that cannot legally be released, including gross negligence, recklessness, or intentional misconduct where prohibited by law.

## 7. Indemnification

I agree to indemnify and hold harmless the Released Parties from third-party claims, losses, liabilities, or expenses, including reasonable legal fees, arising from my violation of safety rules, misuse of firearms or equipment, unlawful conduct, or negligent or intentional acts.

## 8. Property and Equipment Responsibility

I accept financial responsibility for loss of or damage to firearms, equipment, facilities, vehicles, targets, or other property caused by my misuse, negligence, unauthorized modification, or failure to follow instructions, excluding ordinary wear and tear.

## 9. Emergency Medical Authorization

If I am injured or become ill and cannot provide direction, I authorize the Company and its representatives to contact emergency services and obtain reasonable emergency care for me. I understand that I am responsible for medical and transportation costs and that the Company does not guarantee the availability or outcome of emergency treatment.

## 10. Governing Law; Severability; Entire Agreement

This Agreement is governed by New Jersey law. Any provision found unenforceable shall be modified only to the minimum extent necessary or severed, and the remaining provisions shall continue in effect. This Agreement contains the entire agreement regarding the matters addressed and may be modified only in a writing signed by the Company and me.

## 11. Knowing and Voluntary Agreement

I certify that I have read this entire Agreement, understand that it affects important legal rights, have had an opportunity to ask questions and seek legal advice, and sign it knowingly and voluntarily. I understand that my signature is required before participation.
